### Act Now!

The Charitable IRA Rollover permits taxpayers age 70½ to make tax-free charitable gifts up to \$100,000 per year from traditional and Roth Individual Retirement Accounts (IRA). Qualified contributions may be counted toward the Required Minimum Distribution for a donor's IRA account. The provision is effective for tax years 2006 and 2007 only, so you must act by December 31 to take full advantage.
