Recognition— Margaret Phillips - The leadership team and the committee have met. We reviewed the eligibility charts and discussed strategies for generating nominations. In addition we took time to study the charts to gain experience in how to interpret them. One chart is organized by recognition category. The other is organized alphabetically by member name. Some things to keep in mind: The colorful cells in the chart are related to the categories in which years in extension is a criteria. The white cells are not. For all categories it is important to review the descriptions posted on the web as "Chapter recognition process." Strategies for generating nominations: Eligibility lists updated and posted to web for current year chapter nominations; Previous recipients encouraged to nominate; Administrative team give support and encouragement to generate nominees; Recognition Committee make nominations; Board members make nominations; Nominators of previous year's nominees who weren't recognized to re-submit nomination (remind them to obtain supervisor support again); Regional ESP directors review list of those eligible and make nominations and/or encourage those in their region to make nominees; Consider someone who is in your local unit, who you have worked with on a project, you have mentored, who mentored you, who is in your programming block, or yourself. A second committee meeting is scheduled for May 13, 2015.
