Scholarship Loan Program and Travel Study Grants Available

Considering working on an advanced degree or doing a travel study project? Financial assistance is available.

Scholarship loans up to \$1500 each are provided by the Kansas Alpha Rho Chapter of Epsilon Sigma Phi. Priority is for professional study toward an advanced degree. No interest is charged on the loan period of study, but begins at 5% the date study ends.

Travel study grants are also available to members of Epsilon Sigma Phi. A maximum of \$300 is available to an individual for informal study that involves travel. An individual can receive a Travel Study Grant only one time. Travel study must start within one year after award has been approved.

Applications for both the Scholarship Loans and Travel Study Grants are due by June 1, 2004 to Sandra L. Wick, Professionalism committee chairperson.
