#### GRAIN DUST EXPLOSIONS UP SHARPLY IN 1984 OVER 1983

Twenty grain dust explosions were reported in the U.S. to Ralph Regan, F.G.I.S. Safety Director, and Robert W. Schoeff, Extension Marketing and Safety Specialist, Kansas State University. This was a 53% increase over the 1983 low and equal to the 10 year average of 20 explosions.

There were 9 fatalities and 29 injured. Fortunately there were some employees who escaped with only minor injuries. Property damage ranged from none to \$10 million or more. Two grain processing plants were a total loss as were several elevators.

In 8 out of 20 cases the causes were unknown. Fire from various sources, hot bearings and sparks from foreign material were major probable causes. No reports of welding and cutting causing an explosion were welcome news.

Corn was being handled in 12 of the 20 explosions, wheat in four, soybeans in two, corn gluten meal in one and the elevator was closed for a holiday in one case.

Nebraska was the leading state in 1984 with six followed by Illinois with two, Louisiana two, North Dakota two and eight other states with one each.

A breakdown by type of facility shows 12 occurred in grain elevators, five in feed mills, one each in a flour mill, soybean processing plant, corn gluten pelleting plant and a transfer leg between storage and processing facilities. One firm had the primary explosion in the feed mill and secondary in the adjacent grain elevator.
